The undersigned hereby releases, waives, discharges and covenants not to sue the YMCA, its directors, officers, employees, and agents(hereinafter referred to as releases) from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the a YMCA, without respect to location.
2. The undersigned hereby agrees to indemnify and save and hold harmless the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence or the undersigned in, upon, or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating any program affiliated with the YMCA whether caused by the negligence of the releases or otherwise.
3. The undersigned hereby assumes full responsibility for the risk of bodily injury, death, or property damage due to negligence of releases or otherwise while in, about or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

The undersigned further expressly agrees that the forgoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of North Carolina and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal and effect.
